Request to Rezone 7275 North Port Washington Road
(Tax Key Parcel 0978004)
from PD Planned Unit Development District-Hotel
to PD Planned Unit Development District-Multiple Family Residential

PLEASE TAKE NOTICE that the City of Glendale Plan Commission will hold a Public Hearing at the Municipal Building, 5909 North Milwaukee River Parkway, in said City at 6:00 p.m. on Tuesday, February 02, 2016, to consider a request from Jomela Boulder, LLC, to Rezone 7275 North Port Washington Road (Tax Key Parcel 0978004) from PD Planned Unit Development District-Hotel to PD Planned Unit Development-Multiple Family Residential for use as an apartment complex consisting of twelve (12) existing 8-unit buildings. The proposed project plan may be viewed at City Hall.
