PLEASE TAKE NOTICE that the City of Glendale Common Council will hold a Public Hearing at the Municipal Building, 5909 North Milwaukee River Parkway, in said City at 6:00 p.m. on Monday, May 9, 2016, to consider a request from Milwaukee County to Rezone Milwaukee County Owned former Railroad Property (Tax Key Parcels 159-8997-002, 160-9979-000, 169-9993-000, 168-9987-000, 195-8998-000, 196-8995-000, 204-8999-000, and 203-8996-000) to C-1 Conservancy District.
