## 2015 Planned Capital Improvement Program

As a continuation of a long-term agreement with the Milwaukee Metropolitan Sewerage District (MMSD), the 2015 Capital Improvement Program would continue to repair and replace private property sewer laterals. The area of focus will be the Crestwood neighborhood area in the Sixth Aldermanic District.

The proposed program also includes the street asphalt overlays. It is recommended that the following streets be overlay: North Seville Avenue, from West Green Tree Road north to West Rochelle Avenue; North Cedar Ridge Lane, from West Fairfield Court north to terminus; North Cedar Ridge Lane, from West Acacia Road south to terminus; and West Rochelle Avenue, from North Range Line Road west to North Seville Avenue.

The largest program planned for 2015 is the planned construction of West Bender Road, from North Flint Road east to the existing West Bender Road. This project will facilitate the planned development of the former landfill site to a joint Nicolet/Glendale Recreational facility. The street construction would include curb, gutter, sidewalks, utilities and street lighting.

The second major program planned for 2015 is the reconstruction of West Civic Drive from North Milwaukee River Parkway west to the Little League fields. This project will include curb, gutter, storm sewer and a sidewalk on the south side of West Civic Drive from North Milwaukee River Parkway to the Little League fields.

The City is also planning to participate with Milwaukee County on the reconstruction of North Milwaukee River Parkway from West Bender Road north to West Good Hope Road. Milwaukee County will be providing the engineering design and construction, and the City will participate financially for that area located north of West Edward Lane.

## Brush and Yard Waste Collection for 2015

Advanced Disposal Services (the City's refuse collector) will collect brush and yard waste on recycling day starting the week of March 23 and ending the week of November 13, 2015. **Residents do not have to call in and are not charged for the brush and yard waste collection during this period.** Residents with questions about the program may contact Advanced Disposal Services Customer Service at their toll free number (262) 679-0860.

### YARD WASTE PROGRAM

Yard waste includes leaves, garden debris and small twigs. **NO GRASS CLIPPINGS** will be collected. Residents are encouraged to use mulching mowers or compost their own grass clippings.

1. Yard waste materials must be placed in either cans clearly marked with the words "Yard Waste" in two locations, or in 30-gallon paper yard waste bags which are available in local hardware stores. **Plastic bags will not be accepted.**
2. The weight limit of each container must not exceed 50 pounds, or the materials will not be collected.
3. Yard waste mixed with trash will be rejected.
4. Yard waste containers **must be placed at the normal garbage collection point**, off the road pavement, **after 4:00 p.m. the day before recycling day.**
5. Yard waste **SHALL NOT** be placed on cul-de-sac islands, city-owned lots, school property, boulevards or at the end of "dead end" or "no outlet" alleys.

### BRUSH COLLECTION PROGRAM

The City's brush collection program is not a tree removal service. Residents can place approximately 3 to 4 cubic yards of brush at the curb for pick-up. Brush includes tree limbs, bush and hedge trimmings.

1. Acceptable brush sizes shall be less than four inches (4") in diameter and four feet (4') in length.

2. Pile brush neatly (not tangled) in one direction with cut ends facing the street or alley. **Brush considered unsuitably stacked will not be collected.**
3. Brush must be placed at the edge of the street, curb or alley (**the same location as garbage pick-up**) abutting your property only, not extending onto pavement, **by 7:00 a.m. on Monday of recycling collection week.**
4. Brush **SHALL NOT** be placed on cul-de-sac islands, city-owned lots, school property, boulevards or at the end of "dead end" or "no outlet" alleys.
5. The following materials **WILL NOT** be collected: stumps; root systems or parts of roots attached to brush; brush mixed with garden debris; brush generated from site clearing activities; materials resulting from tree pruning or removal at an address other than the collection point; and tree branches greater than 4" in diameter and 4' in length.

### **How can residents dispose of tree branches and logs greater than 4" in diameter?**

- Offer to friends and neighbors for firewood.
- Put a "Free Wood" sign on the pile (maximum size of sign cannot exceed 4 square feet).
- Contract with a private tree contractor.

### **How can residents dispose of stumps?**

- Hire a private tree contractor to grind the stump.

## WATER MAIN FLUSHING

The City of Glendale will conduct its annual water main flushing program from April through July of 2015.

The flushing program is designed to remove natural minerals like iron and calcium that sometimes collect in the bottom of water mains. This operation may cause a temporary discoloration in your water supply. By allowing your water to run for a short period of time, the problem should clear itself. Please be assured, although the water may be discolored, it is safe for human use.

## Noxious Weeds

The City of Glendale reminds residents that State of Wisconsin Statute Section 66.0407 and City of Glendale Ordinance Section [8-1-6](#), require property owners to destroy all noxious weeds on their property. ## SEASONAL STREET PARKING REGULATIONS NOW IN EFFECT

Applications for 2015 City of Glendale overnight parking permits are now available. These applications may be picked up at either of the following locations:

### GLENDALE CITY HALL

5909 North Milwaukee River Parkway  
Hours: Monday - Friday, 8:00 a.m. to 4:30 p.m.

### GLENDALE POLICE DEPARTMENT

5909 North Milwaukee River Parkway  
Hours: 24 hours per day, 7 days per week

Applications are also available on the City's website, which is [www.glendale-wi.org](http://www.glendale-wi.org) (under [Forms and Applications](#)).

Applications may be dropped off or mailed to the Treasurer's Office in City Hall at 5909 North Milwaukee River Parkway, Glendale, Wisconsin 53209.

Each permit issued requires an application. If you have two cars that you wish to park on the street, you must fill out two permit applications. **An annual fee of \$20.00 will be charged for each permit which must accompany the application.**

These permits must be affixed by their own adhesive to the inside of a window on the driver's side of the vehicle. The permits are valid from April 1, 2015 through November 30, 2015.

**Enforcement of the overnight parking ordinance** will begin on April 1, 2015.

Daylight Saving Time begins on

The City of Glendale received notification from the Department of Natural Resources that the National Arbor Day Foundation has designated Glendale as a Tree City USA for 2014. The award serves to recognize communities with outstanding urban forestry programs.

## Landfilling of Invasive Plants

2009 Senate Bill 123 was signed into law as 2009 Wisconsin Act 55. The law makes clear that landfilling of invasive plants is allowable. This ends the confusion between the ban on landfilling yard waste and the allowable disposal of invasive plants. To send bagged plants to the landfill, label the bags as "Invasive Plants — Approved by DNR for landfilling".

## REMINDER

The Public Works Department reminds residents **NOT** to rake leaves or yard waste to the curb in the Spring. Yard waste and leaves will be collected as part of the Brush and Yard Waste Program offered by Advanced Disposal Services. Please refer to the article on page 2 regarding Brush and Yard Waste.

## REFUSE COLLECTION

Per City of Glendale Ordinance [8-3-6](#), all garbage shall be placed at the curbside collection point only after 4:00 p.m. on the evening prior to the regular collection time, and then all refuse containers must be removed from the curbside collection point within twenty-four (24) hours after the regular collection time.

## Responsibilities of Dog and Cat Owners

With pet ownership comes responsibility. Not only are we responsible for the care of our pet, but also for its effect on our neighbors and the community. Most of the local laws covering pet ownership can be found in [Section 7-1](#) of the Glendale Code of Ordinances. Pet owners should be aware of the provisions of this ordinance. Here are some important points:

- It shall be unlawful for any person within the City of Glendale to own, harbor or keep any dog or cat which:
  1. Habitually pursues any vehicle upon any public street, alley or highway in the City.
  2. Assaults or attacks any person or destroys property.
  3. Is at large within the limits of the City.
  4. Habitually barks or howls to the annoyance of any person or persons.
  5. Kills, wounds or worries any domestic animal.
  6. Is known by such person to be infected with rabies or to have been bitten by an animal known to have been infected with rabies.
  7. Is unlicensed.
- No vicious dog shall be allowed off the premises of its owner unless muzzled or on a leash in charge of the owner or a member of the owner's immediate family over sixteen (16) years of age.
- **The owner or person in charge of any dog or other animal shall not permit solid fecal matter of such animal to deposit on any street, alley or other public or private property, unless such matter is immediately removed therefrom by said owner or person in charge.**
- It shall be unlawful for any person owning or possessing an animal, dog or cat to permit such animal, dog or cat to go upon any parkway or private lands or premises without the permission of the owner of such premises and break, bruise, tear up, crush or injure any lawn, flower bed, plant, shrub, tree or garden in any manner whatsoever, or to defecate or urinate thereon.

**With warm weather approaching and residents opening windows for fresh air, please do not leave dogs outside that habitually bark or howl.**

**Residents are requested to report any violations to the Glendale Police Department.**

## National Flood Insurance Program Changes for 2015

Some additional changes to the National Flood Insurance Program (NFIP) will take effect on April 1, 2015 as a result of the Homeowner Flood Insurance Affordability Act of 2014 and Biggert-Waters Act of 2012.

In general, the changes address the affordability concerns raised by the implementation of the 2012 Biggert-Waters Act which led to substantial increases in flood insurance rates as well as some policy changes regarding grandfathering of pre-firm structures. Those changes which will affect homeowner policies in Glendale include:

- Use of the October 2013 rate tables for pre-firm subsidized rates until new rate tables are developed by FEMA.
- Re-establishes pre-firm designation to allow for subsidized rates.
- Requires gradual rate increases to those properties receiving subsidized rates.
- Premium increases for most subsidized properties will increase between 5 to 15 percent annually but no more than 18% annually for an individual policyholder, annually until the premium reaches its full-risk rate. (The previous increase was 25% annually.)
- Establishes a \$25.00 surcharge on all primary residence policies and \$250.00 on all other policies including second homes and businesses.
- Refunds excess premiums for certain policies affected by the pre-firm subsidy elimination under Biggert- Waters.
- New \$10,000 deductible option for residential properties.
- New minimum deductibles for Preferred Risk Properties and Mortgage Portfolio Protection Program policies.
- Premium increases for non-primary residences and Severe Repetitive Loss properties.
- New rate tables for substantially damaged/ substantially improved structures.

## Cardboard Dumpster

City of Glendale residents may dispose of cardboard by placing it in the compactor dumpster just inside the south gate of the DPW yard located on North Glen Park Road. Simply flatten the cardboard before placing it in the dumpster. The gates to the DPW yard are open from 7:00 a.m. to 3:00 p.m. Monday through Friday. For curbside pick up of cardboard, all cardboard must be cut to size and placed inside the new recycling cart.

## West Nile Virus

The City of Glendale Department of Public Works will place mosquito larvacide tablets in all storm sewer catch basins and detention ponds in an effort to reduce the mosquito population.

## HOUSEHOLD HAZARDOUS WASTE DISPOSAL PROGRAM

Bring your hazardous waste, such as pesticides, solvents, fluorescent light bulbs, automotive fluids and other potentially harmful chemicals to the permanent collection facility located at W124 N9451 Boundary Road, Menomonee Falls.

**DO NOT** bring latex paint to the Hazardous Waste facility. Dry out the paint by lining a big box with plastic and fill it with thin layers of paint. Once it's dry, pour in another layer until the paint can is empty. Place newspaper or kitty litter in the box to help absorb more paint. When the paint in the box is dry, throw it all in the normal garbage.

## 2015 Planned Capital Improvement Program (continued)

The existing concrete street pavement on West Bender Road from North Green Bay Avenue east to the Milwaukee River will be repaired.

In compliance with the Wisconsin Department of Natural Resources requirements, the City will be replacing the existing 4 inch water main on North Navajo Avenue from West Good Hope Road south to West Green Tree Road. In addition, the program calls for the City Services building roof to be replaced; the purchase of liquid calcium tanks for the snow plow trucks to aid in snow removal; and funding to continue the City's program on Emerald Ash Borer tree treatments.

Finally, in cooperation with Milwaukee County and the other communities within the County, the City will be participating in the acquisition of new voting equipment. By participating in this program this year, Milwaukee County will absorb 70% of the cost for most of the equipment. The goal of this program is to uniform the voting equipment in all 19 communities within the County.

## Disposal of Large, Bulky or Non-Household Waste

Disposal of large furniture, mattresses, etc. is done by special collection on Fridays **ONLY**. Residents must call Advanced Disposal Services at (262) 679-0860 to schedule a special pick-up for all large, bulky or non-household waste.

Special pick-ups must be scheduled at least two days in advance of the scheduled Friday collection.

Items may be placed at the curb on the night PRIOR to the Friday collection ONLY.

Items must be neatly piled or placed in containers to facilitate easy collection. All collections are done by hand so your consideration for the workers is appreciated.



## EMERALD ASH BORER (EAB)

The Emerald Ash Borer (*Agrilus planipennis*) is an invasive wood-boring beetle native to east Asia. It is believed the pest was transported to the United States from China. It was discovered in southeastern Michigan in 2002 and has since spread to several eastern and midwestern states and Canada. EAB was first discovered in Wisconsin in Ozaukee county, and since then eleven Wisconsin counties have been quarantined, including Milwaukee and Ozaukee counties.

Glendale residents who have ash trees on their property are strongly encouraged to develop a strategy for managing their trees and maintaining property value as the EAB wave moves through the North Shore during the next decade. Treating high-value ash trees on your property to preserve tree canopy is a viable option. Check out the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) Emerald Ash Borer Homeowners Guide at:

The site includes information about how to contact a certified arborist to get professional advice in developing your strategies, as well as information on treating trees to prevent ash mortality. It is important to not delay your planning. Once EAB gains a foot-hold, ash mortality will come swiftly, overwhelming the resources available to remove dead, standing trees.

It is vitally important to have good information about this exotic pest so you can make the most informed decision about the ash trees on your own property, thus helping to preserve the urban tree canopy throughout the City. ## Phone Scams Targeting Wisconsin Residents

The Consumer Hotline at the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) is lighting up with questions about fraudulent telephone calls.

DATCP has recently seen a spike in inquiries and complaints about fake Internal Revenue Service (IRS) phone calls (both "live" calls and robocalls). In this pervasive nationwide scam, a caller falsely claims to represent the IRS and warns the call recipients that they are behind on taxes and must make an immediate payment to avoid arrest or legal actions.

The IRS has issued two separate warnings to taxpayers this year about these operations, and federal agencies have identified **more than 1,000 victims nationwide who have lost an estimated \$5 million** in these tax scams. If you receive a similar call, remember:

- The IRS **NEVER** asks taxpayers to pay their tax bill using prepaid debit cards, credit/debit cards or wire transfers over the phone.
- If the IRS contacts a consumer about unpaid taxes, they do so by postal mail, not by phone.
- Do not be fooled if your caller ID displays "IRS" or the agency's toll-free number.
- Scammers may be able to recite the last four digits of a victim's Social Security number.
- Scammers sometimes send bogus IRS emails to victims after an initial call to support their scam story.

If you receive a threat by robocall, hang up and do not press any buttons during the call.

## RUMMAGE SALES

The Common Council adopted an ordinance pertaining to conducting rummage sales within the City. The following procedures have been established for property owners in order to comply with this ordinance.

The rummage sale registration process is as follows:

- Rummage sales will be permitted on residential property for up to three (3) days per sale with a maximum number of sales per property of three (3) per year.
- No fee will be required.
- A property owner wishing to conduct a rummage sale may come to City Hall and/or City Services during normal office hours or may phone either (414) 228-1705 or (414) 228-1710 and register their proposed rummage sale, provided the following information is given:
  1. Name of property owner
  2. Address of the sale
  3. Dates of rummage sale
- A rummage sale registration must be received no later than noon on Friday for a sale to take place that weekend.
- No fee or permit will be required for a rummage sale sign, provided it meets the requirements of the sign ordinance.
- Any rummage sale signs on City right-of-way, boulevards, medians, City trees, light poles or traffic signs will be removed by either the Police Department, Public Works Department or City personnel without notification to the property owner.

## Thinking About Selling Your Home This Year?

If you are thinking about selling your home this year, remember to apply for a certificate of compliance ahead of time. Many homeowners wait until they have a scheduled closing date to start the code compliance process. However, when inspecting your home, the building inspector may find non-compliant items that are required to be fixed prior to a change in ownership. Apply as soon as possible for your convenience and avoid unnecessary stress on the seller, buyer, real estate agents, and building inspector. To begin the code compliance process, return the code compliance application form (available online) along with payment to City of Glendale. Fees will vary depending on the type of home and number of living units.

Remember to always pull permits for work that is done on your home. Doing so will help you avoid improper work and costly repairs and permit fees.

### Replace your Smoke and Carbon Monoxide Alarms

**Sometimes, simply replacing a battery is not enough.**

Age and environmental conditions can affect the operation of smoke and carbon monoxide detectors. There are actually expiration dates on the back side these devices. If your device does not have an expiration date, it means it is more than 15 years old.

**\*Smoke detectors have a 10-year lifespan**

**\*Carbon monoxide alarms have a 7-year lifespan**

Carbon monoxide detectors should NEVER be exposed to freezing conditions.

If your devices are beyond their listed lifespan, they may not provide the proper level of protection and should be replaced IMMEDIATELY.

(\*May vary slightly based on manufacturer.)

## 9-Volts of Danger?



Spring cleaning time is fast approaching. Did you know that the batteries we rely on to power our smoke detectors, carbon monoxide detectors and possibly even our favorite toy or electronics can be dangerous? That's right, 9-volt batteries can be dangerous if not stored or disposed of properly.

Due to the design of the battery, the positive and negative posts are in very close proximity to one another. Metal that accidentally comes in contact with both posts can create a short circuit, which could result in enough heat to start a fire.

It is unsafe to store 9-volt batteries in close proximity to metallic household items such as coins, paper clips, aluminum foil, steel wool or keys. Even weak batteries may have enough charge left to start a fire if they come into contact with metal objects. There are numerous documented cases of fires as a result of 9-volt batteries that had been disposed of in the trash; which came into contact with other metallic objects in the same trash bag.

Following these few simple steps will help you store and dispose of your 9-volt batteries appropriately:

### Storage:

- Always attempt to keep batteries stored in their original packaging. When this is not possible, always keep the posts of the battery covered with electrical, masking or duct tape to keep them from coming into contact with other metal objects that can complete a circuit.
- Do not store 9-volt batteries in containers or drawers with other batteries.
- Store 9-volt batteries standing up whenever possible.
- Keep batteries stored somewhere safe where they won't be tossed around and have their casing damaged.

### Disposal:

- 9-volt batteries should not be thrown away with regular trash since they can come into contact with other metallic objects. Instead, they should be taken to a hazardous household waste collection facility.
- To be safe, always cover the posts of the battery with electrical, duct or masking tape prior to disposal.
