## 2016 City Budget Summary

With the Governor and State Legislature continuing to make significant changes to the way the State distributes tax revenue to cities, schools and counties and the subsequent reactions from the citizenry, particularly in terms of taxes, has presented a major challenge to Glendale and all communities in preparing a budget that strives to maintain essential city services but at no additional costs. In addition, the nation as a whole continues to recover from the economic recession. Some people remain unemployed, home foreclosures have slowed but still continue, and there appears to be little change in wages in the private sector. The recession continues for many people. Residential property values have slightly inclined, and there are some minor inflationary increases that affect all consumers, including the City. Having to meet these challenges, and yet find the necessary resources to meet these challenges and responsibilities with less revenue, continues to be the story of the 2016 City budget.

In preparing the budget, attention was given to the declining revenue picture. Revenue from the State shared revenue, State transportation aids, recycling financial assistance, and other revenues from the State, were cut significantly in 2012 due to the State budget deficits and have not been restored. In addition, the City's ability to increase revenues has been limited by both the State Legislature, as well as the national economy. In addition, there has been a new State law, which will significantly reduce the amount of hotel room tax the City now uses to reduce the tax levy.

## 2016 City Budget Summary (continued)

With non-property tax revenues declining, expenditures are, unfortunately, in many cases, increasing. The City, like all homeowners, will be facing the increased costs of electricity, gasoline, natural gas and insurance related items. Labor costs, which comprise over 80% of the City's Operation and Maintenance budget, continue to be problematic for the budget.

In addition to these financial challenges, the Governor and State Legislature have continued a tax levy freeze for 2016. Property tax levies are not permitted to be increased from what they were a year ago, with some minor exceptions such as debt service and the rate of net new construction, which for Glendale was 0.11%. The City participates in the State's voluntary expenditure restraint program. This restrictive expenditure program enables the City, if it chooses to participate, to receive an annual incentive payment as a reward for holding expenditures in the general fund at or below the levels from the previous year adjusted by inflation. The City will continue to participate in this program in 2016, and as such, we anticipate receiving approximately \$ 339,000 from the State, the same as this year.

In order to comply with the State mandates, and yet provide essential City services without resorting to any new fees for services required the budget is essentially balanced by decreasing employee costs. This has been accomplished through limited wage freezes, reduced benefit levels, greater employee contributions for fringe benefits, and not filling several vacant police officer positions, as quickly as they should.

The 2016 budget for operations and maintenance totals \$12,819,812, an increase of \$42,167, or less than 1% from the 2015 budget. The total City budget, without TIF but including Debt Service and Special Revenue Funds, is \$19,227,282, an increase of \$240,305 an increase of 1.3% from the current year.

The tax levy will be \$12,469,241, an increase of \$271,163.

## WINTER PARKING REGULATIONS

Glendale's winter parking regulations take effect on December 1, 2015. No parking is allowed on any street between the hours of 2:00 a.m. and 6:00 a.m. from December 1 through March 31. ## PROPERTY TAX COLLECTION PROCEDURE

Property tax bills will be mailed in early December. The bill that you receive will have bar coded payment stubs to speed up processing. You should retain this copy of the tax bill for your records, and return only the bar coded payment stub(s) with your payment(s).

When a due date falls on a weekend it is extended to the next business day, so this year full payments are due February 1, 2016. Optional installment payments are due February 1, March 31, and May 31, 2016 respectively. Special assessments and special charges are not eligible for the installment plan and are due February 1, 2016 along with the first installment. We recommend that you mark your calendar so that you are not late for an installment payment because no reminder notices will be sent.

Mail payments are encouraged because this is an efficient collection process. Please note that the postmark governs the date of payment – not the date on your check.

Payments will also be accepted at City Hall Monday through Friday from 8:00 a.m. to 4:30 p.m., with the following holiday closures: December 24, 25, 31 and January 1. You may also use the permanent collection box located at the front entrance to City Hall. Payments placed in the collection box before midnight on December 31st will be dated December 31st.

We will no longer automatically mail receipts, which will reduce costs and the consumption of resources. Tax details (a form of receipt) and duplicate tax bills will be accessible on the internet at: <http://www.glendale-wi.org>. Payments will appear on this website the day after they are posted.

All payments made on or before the due date, as well as any delinquent real estate tax payments made through July 31<sup>st</sup>, should be made payable to "Treasurer, City of Glendale." Delinquent real estate tax payments after July 31<sup>st</sup> are to be sent to the Milwaukee County Treasurer.

If you have an escrow account, it is your responsibility to contact your lending institution, if necessary, to make arrangements for the payment of taxes, or to provide them with a copy of the tax bill. If you are paying with an escrow check remember that ALL individuals listed as co-payees must endorse the check. If your check exceeds the total amount of tax due, a refund check will be mailed to you in approximately 10 business days.

The tax levy is established by the State of Wisconsin, Milwaukee County, City of Glendale, Glendale/River Hills or Maple Dale/Indian Hills School Districts, Milwaukee Area Technical College, and the Milwaukee Metropolitan Sewerage District to cover their own expenses. Your City tax is the only amount controlled by the City of Glendale. Questions should be directed to each of the taxing jurisdictions regarding their own taxes:

## ENSURING SAFETY THIS HOLIDAY SEASON

As we delve deeper into the winter months and we gather to celebrate the holiday season with family and friends, North Shore Fire/Rescue would like to remind everyone of some safety tips that will help to make sure your celebrations are enjoyable, yet safe.

According to the National Fire Protection Agency (NFPA), almost half of all home decoration fires are started by candles. December is the peak time of the year for candle-involved fires. Numerous flameless candle options are on the market. Several of these options use LED type lighting that provides lighting similar to a real candle but use very low energy and have an extremely long life on a single battery charge.

Similar to the dangers from using real candles, decorating with a real Christmas tree can prove deadly. The NFPA says that although Christmas tree fires are not common, on average 1 in every 40 Christmas tree fires is fatal. In comparison, only 1 in every 142 house fires is deadly. Trees should always be kept at least three feet from any heat source, including: heat vents, candles, space heaters and fireplaces. It is important to always ensure your tree is well watered and that you dispose of the tree shortly after the holiday or when it starts to dry out.

When welcoming guests to your home, ensure they know your home escape plan in the event a fire should occur while they are visiting. Ensure that matches and lighters are secured away from any children that may be visiting and curious about searching through a new environment. Always ask smokers to smoke outside and well away from the house. Provide deep ashtrays or containers made of metal filled with water for the disposal of any smoking material.

Remember to test your smoke alarm monthly and be sure to have a detector on every level of the home and inside and outside of every sleeping area. Milwaukee River Parkway and provides residents with a safe and environmentally responsible way to dispose of unwanted, unused or expired medication, including controlled substances.

The Collection Unit is intended to reduce the amount of unneeded medicine in residents' homes and decrease prescription drug abuse, which has soared in recent years, especially among teenagers.

Glendale's new Drug Collection Unit site is open to the public every day and drugs can be dropped off with no questions asked.



## Income Tax Reminder

Remember that each citizen should use **GLENDALE, WISCONSIN** as their mailing address. This is important when filing income tax returns, vehicle registration forms, and applications for property fire insurance because the City receives a portion of the amount you pay as "shared taxes." By using GLENDALE, WISCONSIN you will also avoid paying a \$20.00 per vehicle wheel tax to the City of Milwaukee.

The City of Glendale receives this shared tax payment ONLY if you indicate your residence as GLENDALE. A significant share of your City Government is paid by "shared taxes."

## BRUSH AND YARD WASTE COLLECTION FOR 2016

Advanced Disposal Services (the City's refuse collector) will collect brush and yard waste every other week from March 21 through November 11, 2016 (see calendar schedule on page 10). Residents who need to dispose of brush or yard waste in the winter months can schedule a pick-up from Advanced Disposal for a fee. The cost is \$30.00 for two cubic yards and \$10.00 for any additional cubic yards. (Note: One yard of yard waste equals one (1) trash can).

## SNOW REMOVAL PROCEDURES



Based upon the expected snowfall this season, we wish to remind you of the City's long-standing snow removal and salting policy.

Normally, the City does not plow streets unless the total accumulation of snow is 3 or more inches. Anything less is typically covered by salting operations.

Salting operations commence generally at the request of the Police Department or at the determination of the City Services Director based upon weather conditions.

Major thoroughfares have first priority. The City does not have a "bare street" program for residential areas. In other words, for residential streets, salting is typically reserved for intersections, hills, mid-blocks and curved roadways.

As much as many people would like, it is impossible for the City to schedule snow removal times to coincide with their respective snow shoveling or snow removal from their driveways. Plowing streets inevitably will put snow on property owner's driveway approaches. There is no other way to plow snow.

If possible, all major thoroughfares will be plowed and salted by morning. Residential side streets will not be completed until the major streets are completed.

As a reminder, the City does not plow or maintain County or State highways located within Glendale. Those streets include North Green Bay Avenue north of West Good Hope Road, West Good Hope Road from North Port Washington Road west to the City limits, West Mill Road, North Milwaukee River Parkway and North Port Washington Road from West Daphne Road north to the City limits.

The City's 10-person Public Works Department will do all that is humanly possible to clear all City streets in a timely fashion. All snow plowing, with the exception of alleys, is done by Public Works employees.

Property owners who have sidewalks will receive a reminder notice of their responsibility to remove snow and ice from their sidewalks. The City is responsible for snow removal on sidewalks that are located adjacent to or on bridges, railroad right-of-ways, and by agreement with Milwaukee County, the sidewalk on North Green Bay Avenue from West Mill Road north to West Green Tree Road.

Please have the appropriate amount of patience and understanding required in this type of climate, with the Public Works Department.

## **SANITARY SEWER BACKUP**

If you experience a basement sanitary sewer backup after hours or on weekends, please call the Glendale Police Department non-emergency number at 228-1753. The Police Department will contact a Department of Public Works employee to investigate the problem.

## **WINTER MAINTENANCE - MAILBOXES**

Please check your mailbox posts to ensure that they are solid and sturdy in the ground prior to winter. Once winter is upon us and the ground is frozen, it is almost impossible to make the needed repairs to sturdy your mailbox. This will ensure that when heavy snow is plowed off the road, your mailbox will not be pushed over.



# HOLIDAY TRASH COLLECTION





## THANK YOU FOR 20 YEARS...AND HERE'S TO 200 MORE.

As the year comes to a close, we also close out a whirlwind year here at North Shore Fire/Rescue. This year not only marked the 20<sup>th</sup> anniversary since the seven communities that make up the North Shore consolidated their fire and rescue services, but also some other very significant milestones.

This year, besides responding to more than 7,000 emergency calls for service, more than ever before in our twenty-year existence; we joined the elite ranks of only 218 fire and rescue agencies worldwide to achieve accredited status from the Commission on Fire Accreditation International. In addition the Public Policy Forum, an independent government watchdog organization who focuses on enhancing the quality of public policy decision making, analyzed the impacts of consolidation and found overall that NSFR is providing a higher level of service than that of pre-1995, and all communities are calculating a cost savings; affirming North Shore Fire/Rescue's position as an international model of successful consolidated public safety service.

In addition, North Shore Fire/Rescue took the lead on a countywide initiative aimed at increasing the number of citizens trained in CPR. Between January and September, more than 600 people have been trained to provide Hands Only CPR and more than 130 have attended additional training with our staff and attained certification by the American Heart Association.


Additionally, nearly 100 child safety seats were inspected and installed by our trained personnel in partnership with the North Shore Health Department and nearly 150 home safety assessments were conducted for senior residents throughout the North Shore. In these assessments, more than 90% of the homes were found to have less than adequate detection and smoke alarms were installed free of charge through grants from Wal-Mart and the National Fire Protection Agency.

None of these accomplishments would have been possible without YOU, our stakeholders. The support of the communities we serve is an integral part of what keeps us on the forefront of innovation. So, on behalf of all of the staff at North Shore Fire/Rescue, THANK YOU for your continued support. We wish everyone a safe and healthy holiday season and New Year. We look forward to future opportunities to exceed expectations and provide first-class service for years to come.

Licenses can be obtained from MADACC's website for a small online servicing fee, or at Glendale City Hall during regular business hours.



## 2016 ELECTION INFORMATION



In order to register to vote, you must be 18 years of age, and have lived in the City of Glendale for at least 28 consecutive days prior to the election in which you wish to vote. Proof of residency is required to register to vote. Proof of residency **MUST** show your current City of Glendale address. Proof of residence documents include:

- A current and valid Wisconsin driver license or identification card
- Any other official identification card or license issued by a Wisconsin governmental body or unit
- A real estate tax bill or receipt for the current year of the year preceding the date of the election
- A utility bill for the period commencing no earlier than 90 days before the day registration is made
- Bank statement
- Paycheck
- A check or other document issued by a unit of government

To register to vote, you can come to City Hall, 5909 North Milwaukee River Parkway. You may also visit [myvote.wi.gov](http://myvote.wi.gov) to register to vote, check your voter registration status, find your polling place, see what's on your ballot, request an absentee ballot (military and permanent overseas voters only).

### **Voter Photo ID Required**

The U.S. Supreme Court has affirmed the photo ID provisions of 2011 Wisconsin Act 23. A photo ID is now required to receive a ballot in all special and regular elections. To learn more about photo ID visit the "Bring it" website at: <http://bringit.wi.gov/>

## A HOMEOWNERS GUIDE TO WINTER

A bit of elbow grease and a few bucks spent weatherizing and winterizing a home not only saves energy costs but can prevent costly repairs. Below are some simple and inexpensive ways to prepare your home for winter.

Examine exterior of house for holes, gaps or cracks in siding, trim, windows, doors, etc. Repairing, replacing, or sealing with a quality acrylic or polyurethane caulk is essential to prevent moisture, insects and rodents from entering. If rodents are a problem, sealing holes and cracks with a mortar based product or silicone caulk will prevent them from entering your house. Clean and flush debris from gutters and downspouts to prevent standing water. Older style hose bibbs (where you attach a garden hose) can freeze and must be winterized. NEVER leave garden hoses attached to a hose bibb during winter. If you are unsure how to winterize older style hose bibbs, contact a licensed plumber. Trim branches overhanging your roof or chimney. Periodically inspect and maintain clearances to sidewall furnace intake and exhaust vents especially after a snow storm where snow piles and drifts can block the intake and exhaust pipes causing a furnace to not operate.

Insulate, Insulate, Insulate! Many older homes lack insulation which helps reduce air infiltration and energy use. A reputable insulation contractor or energy consultant can offer advice. Properly insulating and venting attic areas can greatly reduce energy costs and prevent moisture build up. Draft sealing around windows and doors with permanent latex caulk, weather-stripping, removable caulking, or window insulating kits can greatly increase comfort levels by reducing drafts and cold spots. Inexpensive pre-cut foam insulation inserts can be installed behind light switch and outlet covers to also reduce drafts. Clean bathroom exhaust fan and clothes dryers vents to increase efficiency and reduce risk of fire. Inspect the chimney flue for blockages. Hire a professional to clean your chimney every year. Close fireplace dampers when not in use. Have your furnace or boiler serviced by a professional and change your furnace filter regularly.

Lastly, winter is also a time when deaths from fire and carbon monoxide poisoning occur more frequently. Install a working smoke and carbon monoxide detector on **every** level including the basement. Replace devices according to manufacturer requirements. Older devices may not work properly even if they sound when tested.

## SNOW, ICE & SIDEWALKS SHOVELING FOR SAFETY

All property owners are reminded that Glendale City Ordinance requires all public sidewalks and curb ramps to be kept clear of snow and ice.

Sidewalks and curb ramps must be clear of all snow and ice within 24 hours from the time snow ceases to accumulate.

After each inclement weather event, the City will inspect all sidewalks and curb ramps to ensure they are safely passable.

If a sidewalk or curb ramp is not safely passable, a notice may be posted or otherwise placed at the property indicating the need to comply with the snow and ice removal requirement within a specified time.

Upon re-inspection, any sidewalk or curb ramp not properly cleared will be cleared by the City with all costs and expenses, including administrative fees and/or ice and salt/sand costs charged to the property owner or manager as a special assessment.

Residents are also asked to help keep area fire hydrants cleared of snow to allow easy access in case of a fire.


