2016 PLANNED CAPITAL IMPROVEMENT PROGRAM

As a continuation of a long-term agreement with the Milwaukee Metropolitan Sewerage District (MMSD), the program would continue to repair and replace private property sewer laterals. This program would be funded in large part by MMSD and to a lesser degree by the property owners and the City. For 2016, the area of focus will be the Crestwood neighborhood in the Sixth Aldermanic District. The City will continue to televise and line defective sanitary sewer mains.

The proposed program includes street asphalt overlays. The City Services Director has recommended that the following streets be overlay: North River Forest Drive, from West Riverview Drive South to cul-de-sac; West La Salle Avenue, from North Milwaukee River Parkway east to North River Forest Drive; West Valanna Court, from West Rochelle Avenue east to North Seville Avenue; and West Vera Avenue, from North Range Line Road west to North Seville Avenue.

Planned for 2016 is the planned reconstruction of West Edward Lane, from North Green Bay Avenue east to the Milwaukee River Parkway. The street reconstruction would include curb, gutter, sidewalks on the south side, and utilities including a new water main.

The largest program planned for 2016 is the construction of the City portion of Glendale Community Recreation Center. This program, as was previously presented to the Council, will include the park building (complete with a community room, full concession/kitchen area, storage and athletic rooms), an amphitheater, universal children's play area and veteran's memorial. Based on the successful fund raising efforts, these costs should be re-paid over a ten year period from private funds.

BRUSH AND YARD WASTE COLLECTION FOR 2016

Advanced Disposal Services (the City's refuse collector) will collect brush and yard waste on recycling day starting the week of March 21, 2016 and ending the week of November 11, 2016. **Residents do not have to call in and are not charged for the brush and yard waste collection during this period.**

YARD WASTE PROGRAM

Yard waste includes leaves, garden debris and small twigs. **NO GRASS CLIPPINGS** will be collected. Residents are encouraged to use mulching mowers or compost their own grass clippings.

1. Yard waste materials must be placed in either cans clearly marked with the words "Yard Waste" in two locations, or in 30-gallon paper yard waste bags which are available in local hardware stores. **Plastic bags will not be accepted.**
2. The weight limit of each container must not exceed 50 pounds, or the materials will not be collected.
3. Yard waste mixed with trash will be rejected.
4. Yard waste containers **must be placed at the normal garbage collection point**, off the road pavement, **after 4:00 p.m. the day before recycling day.**
5. Yard waste **SHALL NOT** be placed on cul-de-sac islands, city-owned lots, school property, boulevards or at the end of "dead end" or "no outlet" alleys.

BRUSH COLLECTION PROGRAM

The City's brush collection program is not a tree removal service. Residents can place approximately 3 to 4 cubic yards of brush at the curb for pick-up. Brush includes tree limbs, bush and hedge trimmings.

1. Acceptable brush sizes shall be less than four inches (4") in diameter and four feet (4') in length.
2. Pile brush neatly (not tangled) in one direction with cut ends facing the street or alley. **Brush considered unsuitably stacked will not be collected.**
3. Brush must be placed at the edge of the street, curb or alley **(the same location as garbage pick-up)** abutting your property only, not extending onto pavement, **by 7:00 a.m. on Monday of recycling collection week.**
4. Brush **SHALL NOT** be placed on cul-de-sac islands, city-owned lots, school property, boulevards or at the end of "dead end" or "no outlet" alleys.
5. The following materials **WILL NOT** be collected: stumps; root systems or parts of roots attached to brush; brush mixed with garden debris; brush generated from site clearing activities; materials resulting from tree pruning or removal at an address other than the collection point; and tree branches greater than 4" in diameter and 4' in length.

How can residents dispose of tree branches and logs greater than 4" in diameter?

- Offer to friends and neighbors for firewood.
- Put a "Free Wood" sign on the pile (maximum size of sign cannot exceed 4 square feet).
- Contract with a private tree contractor.

How can residents dispose of stumps?

- Hire a private tree contractor to grind the stump.

Electronic Devices

REPLACE YOUR SMOKE AND CARBON MONOXIDE ALARMS

When simply replacing a battery is not enough.

Age and environmental conditions can affect the operation of smoke and carbon monoxide detectors. There are actually expiration dates on the back side these devices. If your device does not have an expiration date, it means it is more than 15 years old.

***Smoke detectors have a 10-year lifespan**
***Carbon monoxide alarms have a 7-year lifespan**

Carbon monoxide detectors should NEVER be exposed to freezing conditions.

If your devices are beyond their listed lifespan, they may not provide the proper level of protection and should be replaced IMMEDIATELY.

(*May vary slightly based on manufacturer.)

WATER MAIN FLUSHING

The City of Glendale will conduct its annual water main flushing program from April through August of 2016.

The flushing program is designed to remove natural minerals like iron and calcium that sometimes collect in the bottom of water mains. This operation may cause a temporary discoloration in your water supply. By allowing your water to run for a short period of time, the problem should clear itself. Please be assured, although the water may be discolored, it is safe for human use.

Any inconvenience should not last more than a day. If problems persist, or for more information, please call the Glendale Water Utility at (414) 228-1719 or (414) 228-1745.

SEASONAL STREET PARKING REGULATIONS NOW IN EFFECT

Applications for 2016 City of Glendale overnight parking permits are now available. These applications may be picked up at either of the following locations:

GLENDALE CITY HALL

5909 North Milwaukee River Parkway

Hours: Monday - Friday, 8:00 a.m. to 4:30 p.m.

GLENDALE POLICE DEPARTMENT

5909 North Milwaukee River Parkway

Hours: 24 hours per day, 7 days per week

Applications are also available on the City's website, which is www.glendale-wi.org (under Forms and Applications).

Applications may be dropped off or mailed to the Treasurer's Office in City Hall at 5909 North Milwaukee River Parkway, Glendale, Wisconsin 53209.

Each permit issued requires an application. If you have two cars that you wish to park on the street, you must fill out two permit applications. **An annual fee of \$20.00 will be charged for each permit which must accompany the application.**

These permits must be affixed by their own adhesive to the inside of a window on the driver's side of the vehicle. The permits are valid from April 1, 2016 through November 30, 2016.

Enforcement of the overnight parking ordinance will begin on April 1, 2016.

DAYLIGHT SAVING TIME

Daylight Saving Time begins on **Sunday, March 13, 2016.**

Remember to turn your clocks ahead one hour.

The North Shore Fire Department also recommends replacing batteries in smoke alarms and carbon monoxide detectors at this time.



BICYCLE LICENSES AVAILABLE

City of Glendale Ordinance provides that any bicycle ridden on the street is to be licensed. Licenses are available at the Glendale Police Department and sell for a fee of \$10.00. This license is **PERMANENT**.

GLENDALE POLICE DEPARTMENT RECEIVES GRANT FOR DRUG COLLECTION UNIT

The Glendale Police Department has been awarded a grant from CVS Pharmacy to install a Drug Collection Unit. The new unit is in the lobby at the Police department located at 5909 N. Milwaukee River Parkway and provides residents with a safe and environmentally responsible way to dispose of unwanted, unused or expired medication, including controlled substances.

The Collection Unit is intended to reduce the amount of unneeded medicine in residents' homes and decrease prescription drug abuse, which has soared in recent years, especially among teenagers.

Glendale's Drug Collection Unit site is open to the public every day. Drugs can be dropped off with no questions asked.



Tree City USA



TREE CITY USA

The City of Glendale received notification from the Department of Natural Resources that the National Arbor Day Foundation has designated Glendale as a Tree City USA for 2015. The award serves to recognize communities with outstanding urban forestry programs.

REMINDER

The Public Works Department reminds residents **NOT** to rake leaves or yard waste to the curb in the Spring. Yard waste and leaves will be collected as part of the Brush and Yard Waste Program offered by Advanced Disposal Services. Please refer to the article on page 2 regarding Brush and Yard Waste.

LANDFILLING OF INVASIVE PLANTS

2009 Senate Bill 123 was signed into law as 2009 Wisconsin Act 55. The law makes clear that landfilling of invasive plants is allowable. This ends the confusion between the ban on landfilling yard waste and the allowable disposal of invasive plants. To send bagged plants to the landfill, label the bags as "Invasive Plants — Approved by DNR for landfilling" and place in your regular refuse containers.

COLLECTION OF REFUSE

Per City of Glendale Ordinance 8-3-6, all garbage carts shall be placed at the curbside collection point only after 4:00 p.m. on the evening prior to the regular collection time. All refuse carts must be removed from the curbside collection point within twenty-four (24) hours after the regular collection time.

E-CIGARETTES

Electronic nicotine delivery systems (ENDS), which include e-cigarettes are growing in popularity, despite concerns about the health effects of these products. State and national reports monitoring tobacco use trends have documented an increase in the use of these products among youth and adults. Organizations like the American College of Physicians and the American Public Health Association support efforts to regulate e-cigarettes as a tobacco product and encourage public places and workplaces to ban their use.

What is an e-cigarette?

- A device that allows users to inhale a vapor containing nicotine or other substances.
- Unlike traditional cigarettes, e-cigarettes are generally battery-operated and use an atomizer to heat a refillable cartridge that then releases a chemical-filled vapor.
- E-cigarettes are often available in flavors that may appeal to children and teens, including cotton candy, chocolate, strawberry, and mint.

Who is using e-cigarettes?

- Two million high school students in 2014 reported current e-cigarette use according to the CDC's 2014 National Youth Tobacco Survey. Since 2013, the rate tripled from 4.5% in 2013 to 13.4% in 2014.¹
- About 450,000 middle school students in 2014 reported current e-cigarette use. This rate also tripled from 1.1% in 2013 to 3.9% in 2014.¹
- Adult use of these products has also grown with 2.6% of adults reporting that they regularly used e-cigarettes in 2013 up from 1% in 2010.

Are they regulated?

- Currently there are NO regulations to protect consumers on the manufacture or sale of the 450+ brands of e-cigarettes.²

Contents of e-cigarettes vary widely and don't always match the ingredients or amounts listed on the label. In fact, there is no requirement to list ingredients.³

What are the health effects?

- E-cigarettes produce more than just water vapor. The aerosol can contain nicotine, ultrafine particles, heavy metals, and toxic cancer-causing chemicals.⁴

- Nicotine (a primary ingredient in most e-cigarettes) is known to have harmful effects on adolescent brains.⁵
- Further research is needed to understand whether current smokers are switching to these products instead of quitting, using them in conjunction with regular cigarettes, and if children are using these products to initiate tobacco product use.

Can they help smokers quit?

- The FDA has not approved e-cigarettes as a cessation device.
- E-cigarettes users often continue to smoke regular cigarettes as well as use e-cigarettes.

Rules for Lead-Safe Remodeling

In 2010, regulations were placed in effect establishing important requirements for protection from lead exposure during renovating and remodeling work.

The requirements require certifications for lead abatement workers as well as a Federal law requirement that all property owners receive certain information before disturbing more than two square feet of painted surfaces. These include: single family homeowners, apartment building tenants, child care facilities and schools build before 1978 including the families of attending children.

Prior to starting work in pre-1978 housing contractors are required to provide the US EPA *Renovate Right* pamphlet to owners and occupants. They must also post warning signs, restrict occupants from work areas, prevent dust and debris from spreading, conduct a thorough cleanup, and verify that the cleanup was effective.

Some of the more common projects affected by these regulations include interior and exterior painting, window replacement, remodeling or refinishing

Exposure to lead poses severe health risks in adults and especially in young children.

Avoiding Costly Repairs in your Basement

If you've ever experienced water in your basement, whether it has completely flooded, it only leaks during heavy rains, or it just smells bad, you know that feeling of frustration. But water or moisture in your basement isn't something that you should ignore. Uncorrected water issues can lead to very costly repairs and should be addressed sooner rather than later.

Water and moisture enter your basement in several ways; through window wells, wall and floor cracks, mortar joints, sump crocks and drain tile, and even at the top of the wall. Figuring out where the water is coming from is the first step in solving the issue. The best way to figure this out is by visual inspection. Oftentimes, moisture in a wall will leave signs including stains, mold or mildew, peeling or bubbling paint, or a white powdery substance called efflorescence. These are all indicators of moisture within foundation walls.

While there are many ways water can enter a foundation, the simplest way to prevent it is to eliminate or reduce the source of water. Below are a number of things to look for and correct:

- Install gutters and downspouts where missing.
- Extend downspouts and sump pump discharge pipes a minimum of six feet from the edge of your foundation, the further the better. Water should also flow away from the foundation at the point of discharge.
- Inspect the grading around the perimeter of your home. The ground should slope away a minimum of one-half inch for every foot for a minimum of ten feet where possible. Dirt should never be in direct contact with siding or brick.
- Remove bordered gardens and planting areas around foundations. These act like dams and don't allow the water to flow away from your home.
- Replace any driveways, patios or sidewalks that have settled and are sloped towards your home. These directly convey towards your foundation.

Water can enter a basement in any number of ways and the above list is a great place to begin. As always, you can hire a professional to inspect your foundation. Hiring a foundation repair specialist can provide you with proper repair recommendations. If your basement is cracked, bowed or settled, you should consider hiring a foundation engineer to provide you with an unbiased, professional opinion on the necessary repairs or corrections.

2016 PLANNED CAPITAL IMPROVEMENT PROGRAM (CONTINUED)

Milwaukee County will be completing the reconstruction of North Milwaukee River Parkway from West Bender Road north to Green Tree Road. Milwaukee County will be providing the engineering design and construction.

Also planned for 2016 is the replacement of the pumps at the City's water stand pipe located West of North Range Line Road, South of West Good Hope Road. These pumps regulate the flow and distribution, as well as the water pressure, within the City's water system. The Water Utility also plans on installing an antenna for its automatic meter reading program.

In compliance with the Wisconsin Department of Natural Resources requirements, and the history of problems with these water mains, the City will be replacing the water main on North Port Washington Road from West Good Hope Road North to West Mall Road, and the water main on North Atwahl Drive, from West Brantwood Avenue to West Green Tree Road.

DISPOSAL OF LARGE, BULKY OR NON-HOUSEHOLD WASTE

Disposal of large furniture, mattresses, etc. is done by special collection on Mondays **ONLY**. Residents must call Advanced Disposal Services at (262) 679-0860 to schedule a special pick-up for all large, bulky or non-household waste.

Special pick-ups must be scheduled at least a week in advance of the scheduled Monday collection.

Items may be placed at the curb on the night **PRIOR** to the Monday collection **ONLY**.

Items must be neatly piled or placed in containers to facilitate easy collection. All collections are done by hand so your consideration for the workers is appreciated.



EMERALD ASH BORER (EAB)

The Emerald Ash Borer (*Agrilus planipennis*) is an invasive wood-boring beetle native to east Asia. It is believed the pest was transported to the United States from China. It was discovered in southeastern Michigan in 2002 and has since spread to several eastern and Midwestern states and Canada. EAB was first discovered in Wisconsin in Ozaukee county, and since then eleven Wisconsin counties have been quarantined, including Milwaukee and Ozaukee counties.

NOXIOUS WEEDS

The City of Glendale reminds residents that State of Wisconsin Statute Section 66.0407 and City of Glendale Ordinance Section [8-1-6](#), require property owners to destroy all noxious weeds on their property. Some of the more common noxious weeds include thistle, poison ivy, burdock and ragweed. If you have questions, please call the City Services Director at (414) 228-1746.

HOMEOWNER STRATEGIES FOR MANAGING EMERALD ASH BORER (EAB)

Glendale residents who have ash trees on their property are strongly encouraged to develop a strategy for managing their trees and maintaining property value as the EAB wave moves through the North Shore during the next decade. Treating high value ash trees on your property to preserve tree canopy is a viable option. Check out the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) Emerald Ash Borer Homeowners Guide at:

The site includes information about how to contact a certified arborist to get professional advice in developing your strategies, as well as information on treating trees to prevent ash mortality. It is important to not delay your planning. Once EAB gains a foothold, ash mortality will come swiftly, overwhelming the resources available to remove dead, standing trees.

The National EAB Informational Website and the Wisconsin EAB Website (links below) are excellent sources of information. It is vitally important to have good information about this exotic pest so you can make the most informed decision about the ash trees on your own property, thus helping to preserve the urban tree canopy throughout the City. Spread the word to friends and neighbors as well.

MISSED COLLECTION OF REFUSE, RECYCLABLES OR YARD WASTE

If you suspect your garbage, recycling or yard waste collection has been missed, residents must contact Advance Disposal directly at (262) 679-0860. This allows residents to explain, in detail with the service provider, what items are placed for collection and any possible reasons for non-collection.

RESPONSIBILITIES OF DOG AND CAT OWNERS

With pet ownership comes responsibility. Not only are we responsible for the care of our pet, but also for its effect on our neighbors and the community. Most of the local laws covering pet ownership can be found in [Section 7-1](#) of the Glendale Code of Ordinances. Pet owners should be aware of the provisions of this ordinance. Here are some important points:

- It shall be unlawful for any person within the City of Glendale to own, harbor or keep any dog or cat which:
 1. Habitually pursues any vehicle upon any public street, alley or highway in the City.
 2. Assaults or attacks any person or destroys property.
 3. Is at large within the limits of the City.
 4. Habitually barks or howls to the annoyance of any person or persons.
 5. Kills, wounds or worries any domestic animal.
 6. Is known by such person to be infected with rabies or to have been bitten by an animal known to have been infected with rabies.
 7. Is unlicensed.
- No vicious dog shall be allowed off the premises of its owner unless muzzled or on a leash in charge of the owner or a member of the owner's immediate family over sixteen (16) years of age.
- **The owner or person in charge of any dog or other animal shall not permit solid fecal matter of such animal to deposit on any street, alley or other public or private property, unless such matter is immediately removed therefrom by said owner or person in charge.**
- It shall be unlawful for any person owning or possessing an animal, dog or cat to permit such animal, dog or cat to go upon any parkway or private lands or premises without the permission of the owner of such premises and break, bruise, tear up, crush or injure any lawn, flower bed, plant, shrub, tree or garden in any manner whatsoever, or to defecate or urinate thereon.

With warm weather approaching and residents opening windows for fresh air, please do not leave dogs outside that habitually bark or howl.

Residents are requested to report any violations to the Glendale Police Department.

RUMMAGE SALES

The Common Council adopted an ordinance pertaining to conducting rummage sales within the City. The following procedures have been established for property owners in order to comply with this ordinance.

The rummage sale registration process is as follows:

- Rummage sales will be permitted on residential property for up to three (3) days per sale with a maximum number of sales per property of three (3) per year.
- No fee will be required.
- A property owner wishing to conduct a rummage sale may register on the City website at www.glendale-wi.org/rummage, come to City Hall and/or City Services during normal office hours, or may phone either (414) 228-1705 or (414) 228-1710 and register their proposed rummage sale, provided the following information is given:
 1. Name of property owner
 2. Address of the sale
 3. Dates of rummage sale
- A rummage sale registration must be received no later than noon on Friday for a sale to take place that weekend.
- No fee or permit will be required for a rummage sale sign, provided it meets the requirements of the sign ordinance.
- Any rummage sale signs on City right-of-way, boulevards, medians, City trees, light poles or traffic signs will be removed by either the Police Department, Public Works Department or City personnel without notification to the property owner.

SANITARY SEWER BACKUP

If you experience a basement sanitary sewer backup on weekdays between 8:00 a.m. - 4:30 p.m. call (414) 228-1710. If you experience a backup after hours or on weekends, please call the Glendale Police Department non-emergency number at (414) 228-1753. The Police Department will contact a Department of Public Works employee to investigate the problem.

2016 ELECTION INFORMATION

In order to register to vote, you must be 18 years of age, and have lived in the City of Glendale for at least 28 consecutive days prior to the election in which you wish to vote. Proof of residency is required to register to vote. Proof of residency **MUST** show your current City of Glendale address. Proof of residence documents include:

- A current and valid Wisconsin driver license or identification card
- Any other official identification card or license issued by a Wisconsin governmental body or unit
- A real estate tax bill or receipt for the current year of the year preceding the date of the election
- A utility bill for the period commencing no earlier than 90 days before the day registration is made
- Bank statement
- Paycheck
- A check or other document issued by a unit of government

To register to vote, you can come to City Hall, 5909 North Milwaukee River Parkway. You may also visit myvote.wi.gov to register to vote, check your voter registration status, find your polling place, see what's on your ballot, request an absentee ballot (military and permanent overseas voters only).

Voter Photo ID Required

The U.S. Supreme Court has affirmed the photo ID provisions of 2011 Wisconsin Act 23. A photo ID is now required to receive a ballot in all special and regular elections. To learn more about photo ID visit the "Bring it" website at: <http://bringit.wi.gov/>

9-VOLTS OF DANGER?

Spring cleaning time is fast approaching. Did you know that the batteries we rely on to power our smoke detectors, carbon monoxide detectors and possibly even our favorite toy or electronics can be dangerous? That's right, 9-volt batteries can be dangerous if not stored or disposed of properly.



Due to the design of the battery, the positive and negative posts are in very close proximity to one another. Metal that accidentally comes in contact with both posts can create a short circuit, which could result in enough heat to start a fire.

It is unsafe to store 9-volt batteries in close proximity to metallic household items such as coins, paper clips, aluminum foil, steel wool or keys. Even weak batteries may have enough charge left to start a fire if they come into contact with metal objects. There are numerous documented cases of fires as a result of 9-volt batteries that had been disposed of in the trash; which came into contact with other metallic objects in the same trash bag.

Following these few simple steps will help you store and dispose of your 9-volt batteries appropriately:

Storage:

- Always attempt to keep batteries stored in their original packaging. When this is not possible, always keep the posts of the battery covered with electrical, masking or duct tape to keep them from coming into contact with other metal objects that can complete a circuit.
- Do not store 9-volt batteries in containers or drawers with other batteries.
- Store 9-volt batteries standing up whenever possible.
- Keep batteries stored somewhere safe where they won't be tossed around and have their casing damaged.

Disposal:

- 9-volt batteries should not be thrown away with regular trash since they can come into contact with other metallic objects. Instead, they should be taken to a hazardous household waste collection facility.
- To be safe, always cover the posts of the battery with electrical, duct or masking tape prior to disposal.

While we all know the importance batteries play in powering the essentials tools for our daily lives, we must always be sure we are using the utmost care when handling, storing and disposing of them.
